On August 16, 2012 at 5:30 PM a search warrant was executed at 390 CR 552 Bushnell, Florida. The search warrant was in reference to narcotics and illegal firearm sales. This was the result of a 4 month undercover investigation by the Sumter County Sheriff's Office' Special Investigations Squad (S.I.S.).

The S.W.A.T. team was utilized in this investigation to secure the residence. Four suspects were arrested on scene and a fifth suspect was arrested the following day at N.W. 4th street Wildwood, Fl. At the scene investigators recovered two fully loaded 9mm semi-automatic handguns that were in a vehicle along with several of the suspects. Recovered in the residence was a stolen G.P. S. navigation unit, ammunition, drug paraphernalia and over a dozen ecstasy pills.

The Sumter County Sheriff's Office is seeking another suspect involved in this operation Tommy "Kat" Turner 35 years old from Bushnell, Fl. If anyone has information on his whereabouts contact Crimeline at 1-800-423-TIPS (8477)
