OPERATION "STREET SWEEPER"

Drug arrests continue in phase two of countywide operation

Sumter County - Sumter County deputies panned out across southern Sumter County this morning arresting drug offenders in phase two of Operation "Street Sweeper". Operation "Street Sweeper" has been a six month undercover operation conducted by the Sheriff's Special Investigations Unit targeting drug dealers throughout Sumter County. In phase two of the operation, deputies served arrest warrants on 53 drug offenders. To date, 78 drug offenders have been arrested.

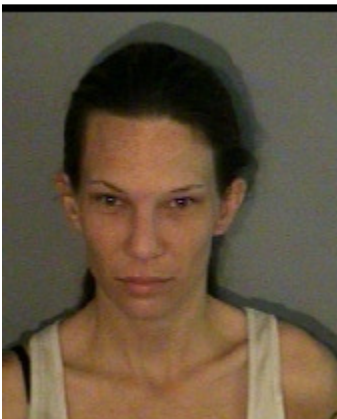

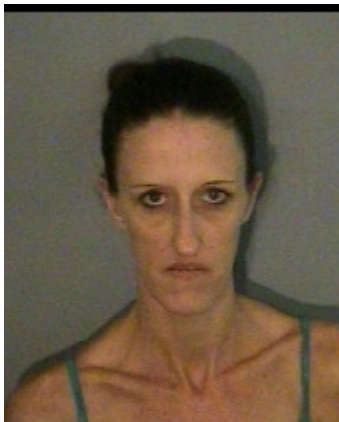

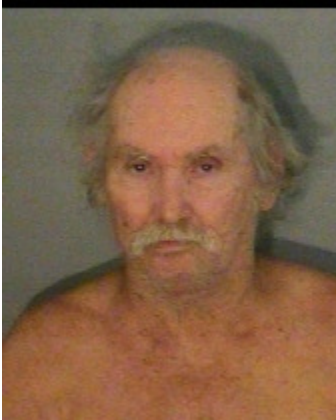
