### **Sumter County Deputies Capture Carjacking Suspect**



On July 29, 2013 Sumter County deputies responded to I-75 to a B.O.L.O. for a black Toyota Corolla that was involved in an armed carjacking from the University of South Florida, Tampa. At approximately 10:35 AM Deputy Jesse Navarro spotted a vehicle that fit the description on I-75 at mile marker 321.

The deputy confirmed the carjacked vehicle by tag number and attempted a felony stop. The suspect continued northbound on I-75 exceeding 100 mph.

The suspect attempted to exit the interstate at SR 44 at a high rate of speed when his vehicle skidded and collided with the raised median. The suspect returned northbound on to the interstate when the vehicle began to smoke from the damage to its undercarriage. The suspects' vehicle crashed over the Marion County line at the weigh station.

The suspect fled on foot into a wooded area. Several back up officers arrived from Sumter and Marion County Sheriff's Offices included K-9 from both agencies. Also at the scene was Tampa Police Department's helicopter that spotted the suspect hiding in the woods. Deputies made the apprehension and the suspected was eventually transported to Marion County Detention Center.
