On April 29th 2014 the Sumter County Sheriff's Office made over twenty narcotics arrests as the result of a three month undercover operation known as Operation Spring Sting. The Sumter County Sheriff's Special Investigation Squad made undercover purchases for cocaine, methamphetamine, crack, oxycodone, hydrocodone, and marijuana and other narcotics. The operation was successfully conducted without incident. During the round-up the Sumter County Sheriff's Special Investigation Squad also arrested Nikki George (pictured below) for a violation of probation resulting from the 2013 Operation Clean Sweep.
