UPDATE Webster Shooting



On July 24, 2014 Sumter County Sheriff's Office positively identified the suspect in the attempted homicide that occurred on July 23rd in Webster as Ivan Mobley DOB 03/03/1987 of Webster, Florida. A warrant was issued for his arrest. At approximately 3:30 PM today July 24th, Sumter County Sheriff deputies spotted Mobley in the area of CR 673 also known as Veteran's Memorial Highway in a cream colored Dodge Magnum and carried out a felony traffic stop; he was apprehended at the intersection of HWY 301 and CR 673. Mobley was transported to the Sumter County Detention Center and charged with the following:

Attempted Homicide

On July 23, 2014 at approximately 3:11 PM the Sumter County Sheriff's Office communications center received a call in reference to a shooting on Fourth St in Webster, FL. The victim, Tony Warthen age 34 of Webster, FL drove himself to the Marathon gas station at 374 N. Market Blvd and contacted law enforcement. Webster Police Department arrived to discover the victim was shot in the facial area, EMS was contacted and he was airlifted by Bay Flight to Orlando Regional Medical Center. The condition of the victim is unknown at this time. The suspect is described as a black male in his mid to late 20's, between 5'07"-5'09" weighing approximately 175-185 pounds. He was last seen fleeing south on CR 727 driving a Gold Toyota Camry. If you have any
