Webster Shooting Suspect Captured

Today, Wednesday September 10th at approximately 0900 a suspect in the Webster shooting incident that occurred on July 24, 2014 was captured at 1825 40th Ave, Sunnyside Park Apartments, Vero Beach, Fl. Lyndon Ford was captured by a joint effort of the U.S. Marshals Florida Regional Fugitive Task Force, the Vero Beach Police Department and Sumter County Sheriff's Office (contact Vero Beach PD for more details). Law enforcement is still looking for a second subject in this case, Patrick Mobley.

Above subjects are fugitives due to the following events. On July 24th at approximately 9PM, Law enforcement received a call in reference to a shooting and responded to the Circle K convenient store on Beville's Corner (State Road 48/State Road 471). Deputies arrived to discover that a subject has been shot. The shooting occurred on N.W. Fourth Street in Webster, Florida.

While detectives were investigating this attempted homicide Law enforcement received a call at approximately 1AM in reference to a shooting into a residence located at

the 4300 block of CR 758, Webster, Florida. Responding deputies discovered multiple rounds of ammunition were fired. The residence was occupied by multiple persons including 3 juveniles, no injuries occurred. The incident resulted in a multi-agency search effort in both Lake and Sumter County but had negative results. Both Lyndon Ford and Patrick Mobley have been on Sumter County Sheriff's top 10 most wanted lists since the incident occurred.
